

# INTERNATIONAL STUDENTS

Faith Bible College has agreed to observe and be bound by the Code of Practice for the Pastoral Care of International Students. Copies of the Code are available from the NZQA website at www.nzqa.govt.nz.



#### **IMMIGRATION**

Full details of immigration requirements, advice on rights to employment in New Zealand while studying, and reporting requirements are available from Immigration New Zealand, and can be viewed on their website at <a href="https://www.immigration.govt.nz">www.immigration.govt.nz</a>.

Each international student (Australian citizens or residents are deemed to be "domestic students" in New Zealand) will be required to enrol as stated, and on acceptance by the College, payment of fees in advance, and return to the College of a signed "Contractual Agreement", will then be issued with a letter of eligibility. The student should submit this letter along with their visa application to the nearest New Zealand Consulate, who will then issue a student visa. To commence a course at Faith Bible College you must have the correct visa; a visitor's permit is not sufficient.

### **ELIGIBILITY FOR HEALTH SERVICES**

Most international students are not entitled to publicly funded health services while in New Zealand. If you receive medical treatment during your visit, you may be liable for the full costs of that treatment. Full details on entitlements to publicly funded health services are available through the Ministry of Health, and can be viewed on their website at **www.moh.govt.nz**.

**ACCIDENT INSURANCE** The Accident Compensation Corporation provides accident insurance for all New Zealand citizens, residents, and temporary visitors to New Zealand, but you may still be liable for all other medical and related costs. Further information can be viewed on the ACC website at **www.acc.co.nz**.

**MEDICAL AND TRAVEL INSURANCE** International students (including group students) must have appropriate and current medical and travel insurance while in New Zealand.

The College is able to arrange this with a reputable insurance company upon request.

**English Language** - Where English is not the first language a student may be required to demonstrate proficiency in written and/or spoken English. To assess this prerequisite the language requirements for entry to mainstream programmes for any student for whom English is a second language are:
